

# INFORMATION ON THE PROCESSING OF PERSONAL DATA

This information is provided pursuant to Articles 13 and 14 of GDPR 2016/679 and national legislation in force. GALDI SRL's newsletter is sent via email to those who explicitly request it, by filling in the form on this page and authorizing GALDI SRL to the processing of their personal data. Data provision is optional. Refusal to provide data entails the impossibility to receive the newsletter.

Legal basis of processing: the legal basis of processing, for promotional and communication to third parties purposes only, is the consent of the data subject.

# Purposes of processing

The personal data provided by the users are used to enable GALDI SRL to:

Send official information (opening and closing times, etc.);

# Methods of data processing

Collected data are processed using IT and electronic tools.

Appropriate security measures are observed to prevent data loss, illicit or improper use and unauthorized access.

#### Data controller

The data controller for collected data is GALDI SRL, Via E. Fermi, 43/b - 31038 Paese (TV), Italy.

The processing of data related to the newsletter service takes place at the above-mentioned registered address and is carried out by the company's employees.

### Data processor

Pursuant to Art. 28 of EU Reg. 2016/679 and current national legislation in force, BIZEN SRL is our designated external data processor, as provider of services for the development and maintenance of the web platform, and also for the supply and operational management of the technological platforms in use.

#### Rights of the data subject

The data subject shall have the right, at any time, to obtain confirmation as to whether or not personal data concerning him or her exist and to know their content and origin, to verify their accuracy or request their integration, update or rectification (Articles 15-22 GDPR 2016/679 and national legislation in force).

The same article grants the right to request the cancellation, anonymisation or blocking of data processed in violation of the law, and to oppose their processing for legitimate reasons.

Data subjects who consider that the processing of their personal data carried out through this service is in breach of the provisions of the Regulation have the right to lodge a complaint with GALDI SRL, as foreseen in Article 77 of the GDPR 2016/679 itself or to take appropriate legal action (Article 79 GDPR 2016/679).
